

SACRAMENTAL PREPARATION

BAPTISM:

If your student **HAS NOT** been baptized, please contact Father Roger to schedule your baptism class.

If your student <u>has</u> been Baptized, but was <u>not</u> baptized at Holy Cross, San Luis or St. Ann, a certified copy of his her Birth Certificate <u>and</u> a copy of the Baptismal Certificate must be submitted to the Parish Office prior to the student's reception of the Sacraments.

FIRST RECONCILIATION AND FIRST HOLY COMMUNION:

The second graders will prepare for two Sacraments: First Reconciliation and First Holy Communion. These Sacraments will be celebrated during the second semester of classes. Parents | Guardians will be informed of special dates and events specific to these sacraments as the year progresses. Dates below are tentative and are subject to change.

Reconciliation: April 21, 2018 First Communion: April 29, 2018

CONFIRMATION:

Candidates will complete a 2-year formation program during which time he/she will be obligated to accumulate service projects and attend spiritual retreats. Parents | Guardians will attend an orientation meeting at the beginning of the school year to receive an overview of the 2-year program. In addition, supplementary communications and materials will be distributed as the need arises. CONFIRMATION RETREATS:

NOTE: Transportation to and from any and all required retreats will be the complete and total responsibility of the parent or guardian. <u>Holy Cross will not be responsible</u> for transporting volunteers or students due to new policy and procedures in effect by the Catholic Diocese of Victoria. MANDATORY RETREAT FORMATION TRAINING FOR CATECHISTS AND VOLUNTEERS

The Retreat Formation/Policy and Procedure Training has been mandated by the Diocese of Victoria. This two-hour training is required for all adults, young adults, and youth that are staffing or in leadership positions on any retreat involving our young people. (Example of retreats include Teen ACTS, Confirmation retreats, summer retreats, Steubenville Conference, etc.) More information will be provided when training classes are scheduled.

EXPECTATIONS FOR PARENTS AND GUARDIANS

- Ensure that their student attends class regularly and on time.
- Communicate any special needs or circumstances that may affect their students in the classroom.
- Notify the parish office of changes of address and/or phone numbers,
- Be an active part of their student's learning and be involved in the classroom by striving to:
 - o Attend Mass weekly and make daily prayer a part of your home
 - Assist students with required prayers, test reviews and volunteer service hours
 - Attend any parent class that is required as part of a Sacrament and/or attend any required sessions in the Safe Environment program
 - Share your own faith with your child as often as possible

EXPECTATIONS FOR STUDENTS:

- Behave in a Christian manner at all times, showing respect and being cooperative with adults and other students.
- Dress appropriately for classes and all Church sponsored events.
- Actively participate in classroom activities and discussions.
- Attend class weekly, complete all homework assignments and attend all required sessions in the Safe Environment program.
- Show respect or others and others property at all times.
- Do not use or possess tobacco or tobacco products. Do not use or possess alcohol or illegal drugs. Do not use or possess any weapons, knives or firearms. This includes attendance at class or retreats, on or off campus.

Failure to comply with these rules will result in expulsion from the program and <u>persons who violate policies governed by law WILL BE reported to the authorities</u>. Please note that the discipline plan is included in this handbook on page 13.

EXPECTATIONS OF CATECHISTS:

- Be a Christian role model, by providing a loving atmosphere within the learning environment so that every student feels accepted and safe
- Prepare and teach the designated curriculum
- Communicate regularly with and involve parents in the faith development of their students
- Attend teacher meetings, trainings and all required sessions in the Safe Environment program and to strictly follow the Code of Conduct as stated
- Keep confidential all student information and concerns

VOLUNTEERS PARTICIPATION IS WELCOME!

Changes to the Diocese of Victoria policy for classroom Adult | Student ratios are as follows:

Jr. High & Younger: 1-12 students: 2 adults 13-18 students: 3 adults 18-24 students: 4 adults

High School: 1-16 students: 2 adults 17-24 students: 3 adults

We are also required to provide 2 additional volunteers as hall monitors during all religious education sessions. **Please consider volunteering**. Volunteering may include clerical help, catechists, hall monitors, classroom aide or chaperone, etc. Some jobs are weekly, some are occasional, but **all are greatly appreciated!!!**

HOW TO VOLUNTEER:

- 1. Visit www.victoriadiocese.org and click on the "NEW VOLUNTEER" tab. Follow online instructions to fill out the application.
- 2. Register and attend a Safe Environment workshop within 90 days of filing the online application. Workshops are held throughout the year in the diocese, and at Holy Cross as required.
- 3. Contact the Parish Office at 564-2893 if you have any questions or need help to apply online.

THE SAFE ENVIRONMENT PROGRAM

All children have the right to be safe and protected from harm in any and all environments. The Catholic Diocese of Victoria is dedicated to ensuring the protection of all children|youth. As part of the Safe Environment Program, every adult volunteer working with children at any time is required to take the Safe Environment program training classes and have a clear background check. No adult is allowed to work with students in any form without this program being completed within 90 days of the beginning of volunteering or employment. Please check with the parish office if you are interested in attending a Safe Environment Training Class. Only re-certification is available online for current employees or volunteers. Parents | Guardians are welcome to visit the classroom at any time but they may not be left alone with or interact with the students without this training protection.

Unfortunately many young people have experienced the trauma of physical abuse and neglect and/or sexual abuse. Catechists may learn of such abuse from a young person or see the signs of such abuse due to regular contact. When we learn of such situations, we have a moral and legal obligation to take action.

Texas state law states in Section 34.01 of the Family Code:

A person having cause to believe that a child's physical or mental health or welfare has been or may be adversely affected by abuse or neglect by any person shall report in accordance with Section 34.02 of this code.

CONTACT CIVIL AUTHORITIES:

Any case of abuse or suspected abuse should be reported to civil authorities.

Contact the local or state law enforcement agencies or the Texas Department of Protective and Regulatory Services: 1800-252-5400 – If a person is in immediate danger call 911.

If you have any questions about whether or not you should report a suspected case of abuse or neglect please call the hotline. They can advise you on whether the signs you have observed are abuse.

IF CHURCH PERSONNEL IS INVOLVED:

In the event the suspected abuser is a priest, deacon or member of the religious community, or a layperson either employed by or in volunteer service of the Diocese of Victoria, you must follow the steps outlined in the Diocesan Policy. The Victoria Diocese also requires children enrolled in the Holy Cross Religious Education program and their parents to attend training sessions in the Safe Environment Program. These training sessions are held during the school year and listed in the Holy Cross Religious Education Schedule. This catechesis helps children youth and parents guardians with basic safety skills, recognition of dangerous and abusive situations, and the ability for children youth to identify trusting adults with whom to speak. It is important that everyone be present at the scheduled training sessions. Holy Cross parish is required to report attendance for these training sessions and your compliance is appreciated. Sessions will be listed in the weekly church bulletin as well as on the Religious Education Schedule.

Parents will be expected to attend and comply with all Safe Environment Requirements required by the diocese.

DIOCESE OF VICTORIA TRANSPORTATION POLICY

The following policies apply to all drivers, whether employed or in a volunteer capacity who are transporting young people or adults or whose regular duties require the driving of motor vehicles in the Diocese of Victoria. Any discretionary items in the policy will be decided by the Diocesan Transportation Committee (DTC). A designated driver/transportation individual will be designated for each parish/school for record keeping purposes. An alternate must also be designated in case of absence or illness or original designee. The names of these individuals should be provided to the Diocesan Business Office on or before July 1, 2011. Changes to record keeping designees must be submitted immediately.

- 1. Drivers must be 25 or older.
- Drivers must have completed the appropriate Safe Environment requirements of the Diocese of Victoria and be approved to drive.
- 3. Drivers must have a valid Texas driver's license. Drivers having licenses from other states or government entities must be approved by the DTC in order to be utilized.
- 4. Drivers must have completed a Motor Vehicles Records check for all states where one has resided for the past 5 years. One must be approved to be utilized as a driver by the Diocese of Victoria and the parish/school where one is transporting young people/adults/or property.
- 5. Driver's approval is at the discretion of DTC or the Bishop of the Diocese. The following minimum standards for unacceptable drivers include but are not limited to drivers who in the past seven years have one or more of these serious violations: Driving under the influence of alcohol or drugs; Hit and Run; Failure to report an accident; Negligent homicide arising out of the use of a motor vehicle; Operating during a period of suspension or revocation; Using a motor vehicle for commission of a felony; Operating a motor vehicle without owner's authority (grand theft). Permitting an unlicensed person to drive; Speed Contest; Sexual misconduct. A motor vehicle record check will be performed every three years. Drivers are required to notify the parish/school if there is any change (i.e., moving violations) during the three year period.
- 6. Drivers must have proof of insurance on the vehicle they are driving that has a minimum liability limit of \$100,000 per individual/\$300,000 per accident/50,000 property damage.
- 7. A Driver Information Form must be kept on file at the parish/school for all vehicles. Catholic Mutual, a member of the DTC or other persons designated by the DTC, will make inspection of these files on periodic bases.
- 8. A Driver Acknowledgement Form must be kept on file for all drivers, and be updated and renewed (signed and dated) annually.
- All occupants of the vehicles must wear Seatbelts. In vehicles, such as buses, that are not equipped with seat belts, all must remain seated while the vehicle is in motion. Vehicles smaller than an 11-passenger vehicle must be equipped with functioning seat belts.
- 10. The vehicle must have a valid and current registration and valid and current license plates.
- 11. All drivers are required to obey posted maximum and minimum speed limits. During periods of heavy traffic, inclement weather, low visibility, or other poor driving conditions, speed must be adjusted so that accidents will be avoided.
- 12. Drivers must be in good health and be physically capable of driving safely. If one is taking medication that impairs judgment, suffering from extreme fatigue, or impaired in any manner, one must refrain from driving.
- 13. Eleven to fifteen passenger vans MAY NOT be used to transport young people or adults.
- 14. Drivers must refrain from talking/communicating on any handheld or hands free device while driving young people or adults.
- 15. Young people or vulnerable adults should never be left unattended in a vehicle.
- 16. Young people/vulnerable adults who have a medical condition that is likely to require additional support/medication must travel in the same vehicle with a parent or staff member who is trained in administering support/medication.
- 17. Drivers must comply with driver's license restrictions, if applicable.
- 18. All state laws should be followed when fueling a vehicle.
- 19. Employees who drive a diocesan/parish vehicle or their own vehicle, as part of their employment, must complete a defensive driving course upon employments and thereafter every three years. Documentation or satisfactory completion of defensive driving course will be submitted to the parish/school designee and retained at the parish/school. Defensive driving may be obtained online through Catholic Mutual (note link will be provided in final publication) Certificate of completion must be submitted 10 days before being utilized as a driver.

ADDITIONAL GUIDELINES WHEN TRANSPORTING YOUNG PEOPLE

Two adults who are in compliance with the requirements of the safe environment policy of the Diocese of Victoria must be present at all times in vehicles that are transporting young people.

- 1. Use of cell phones or other handheld devices are prohibited by the driver.
- 2. Young people shorter than 4 feet 9 inches or less than 100 pounds must ride in a car seat or booster seat.

ADDITIONAL GUIDELINES FOR BUSES

- 1. Driver must have a CDL Class B license with a passenger endorsement and a copy of such must be on file in the parish/school office.
- 2. Driver must be certified in school bus safety. Continuing education in school bus safety is required in accord with the recommendations of the Texas Department of Public Safety.
- 3. Driver may be subject to random drug testing.
- 4. Driver may not use a cell phone or other handheld device.
- 5. When utilizing drivers from a school district or charter bus company: These drivers are not required to attend the diocesan mandated safe environment training, but the required ratios of safe environment compliant adults must be on the bus when transporting young people.
- 6. A minimum of two adults who have completed all of the requirements of the safe environment policy of the Diocese of Victoria must be present at all times in vehicles that are transporting young people.
- 7. Additionally there must be a ratio of 1 safe environment compliant adult for every 10 young people on a bus. The bus driver is not to be included in this ratio, as his/her job is to drive and not to chaperone the young people on the bus.

DIOCESE OF VICTORIA CODE OF CONDUCT

A signed copy must be submitted by all personnel and volunteers

Our children are the most important gifts God has entrusted to us. As someone working in the ministry of Religious Education for the parishes of Holy Cross and the missions of San Luis and St. Ann, I promise to strictly follow the rules and guidelines in the *Code of Conduct* as a condition of my providing services to the children and youth of our parish.

I WILL:

- Treat everyone with respect, loyalty, patience, integrity, courtesy, dignity and consideration.
- Avoid situations where I am alone with children youth at church activities
- Use positive reinforcement rather than criticism, competition, or comparison when working with children youth.
- Refuse to accept expensive gifts from children youth or their parents guardians without written permission of the pastor.
- Refrain from giving expensive gifts from children youth without prior written approval from the parents guardians.
- Report suspected abuse to the pastor and the **Texas Department of Protective and Regulatory Services at 1-800-252-5400**.
- I understand that failure to report suspected abuse to civil authorities is, according to the law a misdemeanor.
- Cooperate fully in any investigation of abuse or children youth.

I WILL NOT:

- Use, possess or be under the influence of alcohol at any time while volunteering
- Use, possess or be under the influence of illegal drugs at any time
- Pose any health risk to the children youth (i.e., fevers, contagious illness)
- Strike, spank, shake or slap any child youth for any reason
- Humiliate, ridicule, threaten or degrade any person, adult child youth
- Touch a child youth in a sexual or inappropriate manner
- Use any disciple that frightens or humiliates children youth
- Use profanity in the presence of children youth

Each person working in the Holy Cross Religious Education program will be subject to a background check including criminal history. Each person understands that any action inconsistent with the *Code of Conduct* or failure to take action mandated by this *Code of Conduct* may result in his or her removal from this ministry.

CATECHISTS, AIDES AND CHAPERONES | HALL MONITORS

All teachers, aides and helpers are volunteers and deserve, and will get the utmost respect from everyone involved. They give countless hours preparing for their classes and attending training sessions. They show up every week to share their love of God with your children. The entire Religious Education program could not exist without their dedication to the faith development of the children in our parish. **Parents|Guardians are needed and urged to volunteer in the program**. If you are interested please contact the parish office. Dedication to your faith and a love for children|youth are the key characteristics of those who seek to work in this ministry... everything else can be taught. Please, prayerfully consider being involved.

All information about your child|youth will remain confidential. Please let the catechist or the parish office know if you have a student that may need modified work or other accommodations. We are here to assist you, the parents|guardians with the students' faith development, as Parents|Guardians are the first and best catechists of the faith.

If a problem arises with a catechist, please seek to solve it by meeting with them privately. If you still have a concern please contact Father Roger Hawes at the parish office and every attempt will be made to work with you for the good of the student.

ATTENDANCE

All Religious Education classes are held in the Holy Cross Activity Center.

Pre-K and K-5th Grade Sunday, after 10:40 am Mass to 11:45 am (please escort your children to class to ensure teachers

are present before leaving)

Grades 6-10 Wednesday 6:30 to 8:00 pm

Grades 11-12 To be determined

Students are expected to attend all scheduled classes. It is important that your student(s) attend classes regularly and consistently; even with make-up work a student who misses a lot of classes will be at a disadvantage. Attendance is recorded each time class meets. All attendance records are kept in the students permanent records on file in the parish office at the completion of the year.

If you know in advance that your student will be absent, please inform the students' catechist or the parish office the week prior to the absence. If your child will be missing some classes on a regular basis (i.e. shared custody) contact the parish office or your students' catechist so your situation can be addressed.

ARRIVAL AND DEPARTURE OF STUDENTS

Before dropping off your child, make sure teacher/aides are there, because there are times when mass runs over and we don't want children left unattended. All students should be picked up promptly to ensure their safety but, also, to be respectful of the catechists. Always remember to value and appreciate the generous time every catechist volunteers towards the success of the Holy Cross Religious Education program. Transportation to and from all classes and events retreats sponsored by the Victoria Diocese and/or Holy Cross Church will be the responsibility of the parents guardian.

STUDENT ILLNESS

In case of student illness or similar emergency, the catechist will notify the parent|guardian and make arrangements for the student to be picked-up immediately. For this reason it is important that we have a working number where you can be reached when your child|youth is in class. When a parent|guardian cannot be contacted, the person listed as your 'emergency contact' will be notified. Please let us know promptly if you have a change in telephone number or if your emergency contact has changed.

HEALTH CONCERNS AND MEDICATION

The policy of the Holy Cross Religious Education program is for no catechist or other personnel in the program to administer medication to a student. However, in cases of great need, medication will be distributed with the signed permission of the parent | guardian of the student. If your child | youth is on medication that makes him/her extremely sleepy or has other side effects please let the catechist or aide know in advance. If the student is on medication for hyperactivity, please make sure that his/her medication is in effect during religious education time. Health concerns should be brought to the attention of the Catechist and Director of Religious Education during registration and updated as the need arises. As a matter of policy, please do not allow your child | youth to bring either prescription or non-prescription medication on campus. Please let us know if your student has an allergy to any food items. Both catechist and parish office should know of any medical condition that might warrant a need for extra caution or supervision. All information will remain confidential.

COMMUNICATIONS

Cell phones and tablets may be brought on campus, but they must be silenced before class time and/or collected before class to minimize distractions. If any device sounds during class time, the device will be brought to the catechist and will be returned to the student after class.

If for some reason, you need to reach your student during class, call the parish office and arrangements will be made to contact your student immediately. Students will always be permitted to return a call to their parents.

Parents | Guardians will be kept informed of upcoming events during the school year through newsletters and memo's and notes from the student's catechist. Catechists also send home reports and tests; please check with your student(s) weekly.

DISCIPLINE AND PROBLEM SITUATIONS

All students are expected to share in the faith learning experiences of the Holy Cross Religious Education program. The behavior of students should reflect respect. Each student has a responsibility to his/her fellow students and the catechists and staff to create and maintain a Christian atmosphere.

The principles are respect others, and their belongings; Respect all parish school property. Be prepared to learn by being prepared for class; Share your faith; Do your own work; Show appropriate behavior in the classroom and hallway; be mindful that the Church is a sacred place and it is to be treated as such.

Parents | Guardians are the resource for help with a behavioral need. The catechist and Pastor will seek the parents | guardian suggestions as to the cause of inappropriate behavior. This collaboration will result in positive approaches to working with and/or ending the behavior. If a student's behavior disrupts the learning process for himself/herself or for others, the steps listed will be followed to ensure that class participation may continue. Behavior appropriate for the Holy Cross Religious Education classroom is equivalent to that extended in the school setting. Catechists will use positive discipline methods when needed to reinforce those expectations. The Holy Cross Religious Education program discipline procedure is based on rules and consequences. There are few rules but they must be enforced clearly, concisely and consistently.

CONSEQUENCES OF ACTIONS OF STUDENTS

- At the first incident the student will be reminded of expected behavior and the consequences of misbehavior
- After the second incident, the student will be sent to the pastor about appropriate behavior and possible solutions to the problem. A disciplinary letter, written by the student explaining his/her fault is mailed to the parents on the next business day.
- After returning to class if there are repeated problems the students' parent|guardian will be called.
- Severe problems or ongoing problems may result in the dismissal from the program, or parent|guardian attendance may be required to continue in class.
- Any student caught with illegal substances (i.e., drugs or alcohol, etc.) will be turned over to legal authorities.

REPORTS AND TESTING

Standardized pre- and post-tests are given to all students in grades 1-5. Catechists also give chapter reviews and finals in all grades. You will be sent reports letting you know the progress of your students. If, at any time, you have questions please check with the parish office.

EMERGENCY CLASS CANCELLATION

If local schools are closed due to an emergency situation, Holy Cross Religious Education classes will be cancelled. If there is a weather concern, classes may be cancelled. If there is a severe weather emergency before students arrive at religious education, classes will be cancelled. If the weather emergency arises after classes begin, the parent|guardian may pick up their student(s) early. All students will be moved to downstairs in the Activity Center and the parent|guardian will pick them up from there.

FIRE SAFETY AND DISASTER PREPARATION

Fire drills will be conducted in accordance with the local fire department. Each catechist and classroom has an evacuation site and procedure to follow. We will conduct unannounced fire drills during the year. Plans for other natural disasters are in place and may be viewed in the parish office or you may check with your student's catechist. All students are expected to follow the catechist and adult instructions. Parents | Guardians are asked to pick up students downstairs in the event of a situation that requires early dismissal and vacating the campus. The Activity Center is located on the East side of the parking lot.

RIGHT TO AMEND

This handbook is primary a means of communication. It is meant to provide you the parent|guardian, with helpful information on how we intend to go about our work. The Holy Cross Religious Education Program reserves the right to amend this handbook as necessary. Parents|Guardians will be notified, in writing, if changes are made to any procedures or information contained in this handbook.
